Report on workshop: Post Pandemic Industrial Landscape

Date: 26/3/2022

The institute organized a one day workshop on, "Post Pandemic Industrial Landscape", under IQAC. The guest speakers were Dr. Sanjay Lakade, Dr. Deepti Lele, Mr. Sunil Patil and Prof. Vijay Chavan. Dr. Anand Padle welcomed the audience and the workshop began by lightening of the lamp. Dr. Satish Ubale, the Director of the institute addressed the audience to highlight the objective of this workshop.

Dr. Sanjay Lakade spoke on the topic, "Intellectual Property Rights". He made the students understand the overview of intellectual property Rights. He started the session by introducing the basics of the concept, like meaning of IPR, world patent application statistics, scenario of patent filing in the world. Dr. Sanjay discussed the types of IPR. Patents, copyrights, geographical indications, industrial designs, trademark, layout designs of integrated circuits, trade secrets, databased. Patents are to protect own property, to create identity, to earn wealth. The patent procedure was discussed in detail. Trademarks can be names, designs, logo, slogan, symbols, sounds, smells, colours, and packaging container or any other devices or even a combination of the above. A copyright is the exclusive legally secured right to publish, reproduce and sell the matter and form of a literary, musical, dramatic or artistic work. Copyright is designed primarily to protect an artist, publisher, or other owner against any unauthorized copying of work. Types of copyrights include literary works, musical works, Dramatic works, Artistic works, Cinematograph films, Sound recordings, computer programs and software.

The geographical indications include the Kolhapuri chappal, Agra ka Petha, Paithani from Pathan were the examples quoted. The industrial designs include layout designs of integral circuits. The trade secrets includes the composition of drugs in pharmaceuticals, chemical industries, fertilizers are some examples. Industrial production gets security by such provision.

The next speaker, Dr. Deepti Lele, Cyber law trainer, spoke on various facets of cyber security measures. She began the session by explaining the term 'Responsible Netizen'. Those who follow, safe and responsible use of information and communication technologies are known as

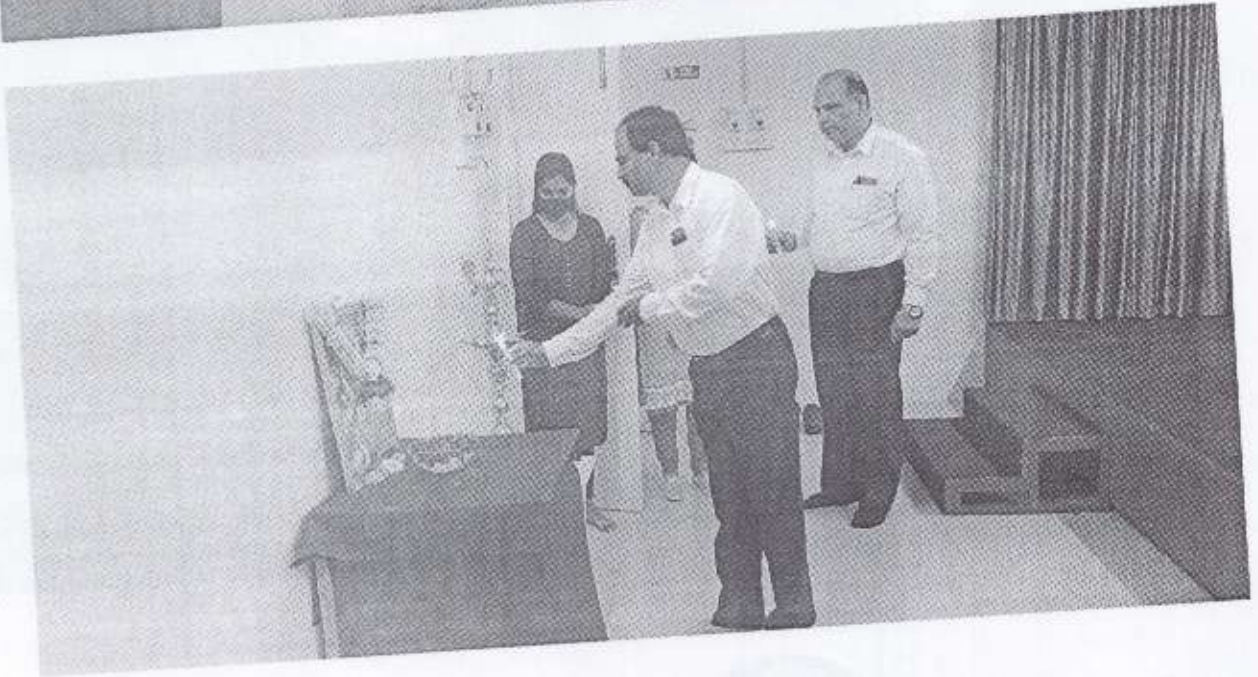
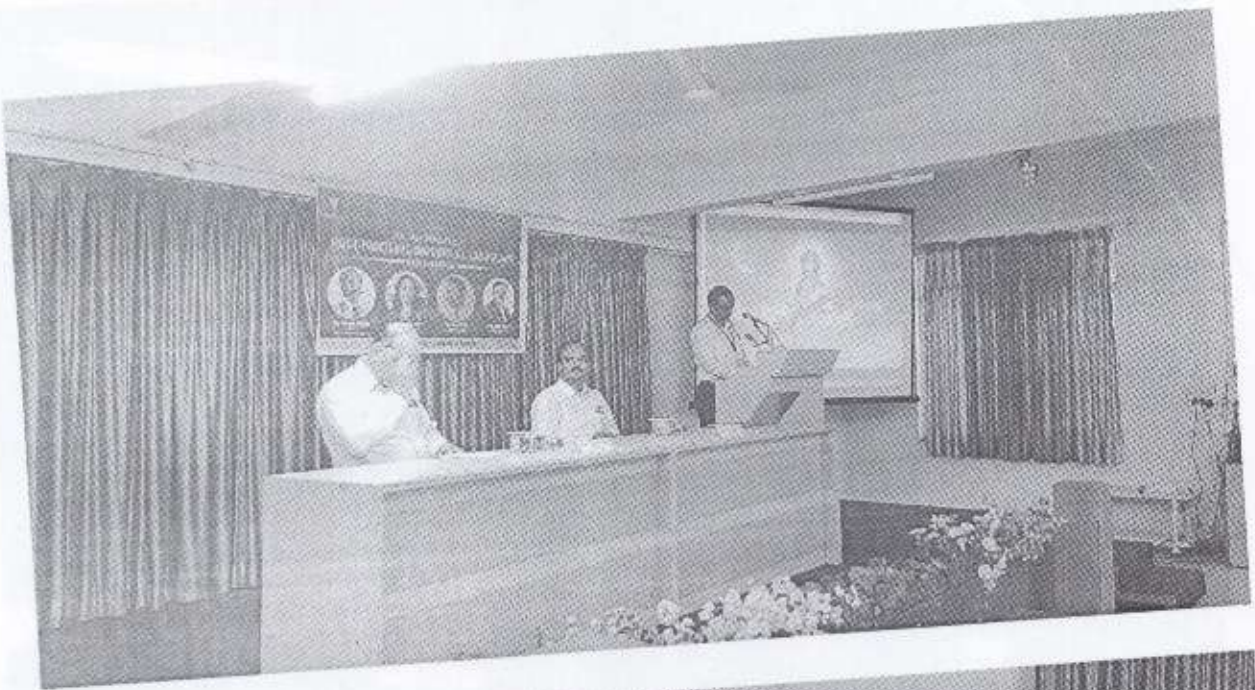


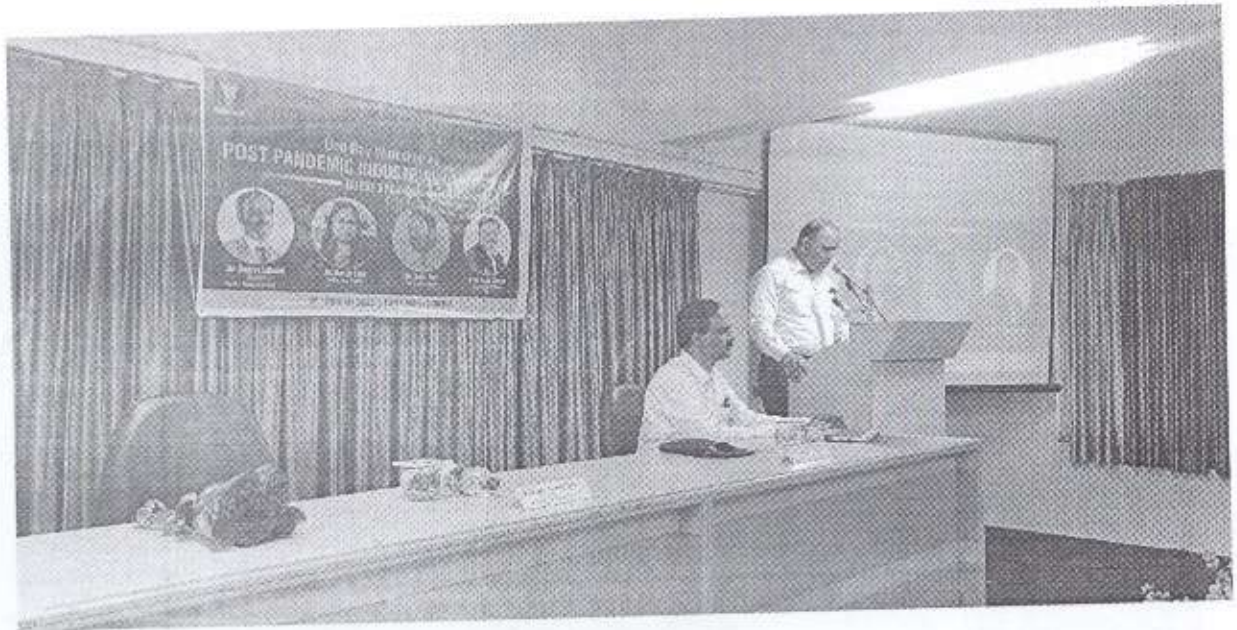
'Responsible Netizen' and they should protect themselves and their family from cybercrime and vulnerabilities. To protect digital identity and security is an important aspect in online business or purchasing. The problem in cyber security can lead to financial damage. Reputational damage and legal damage. Dr. Lele spoke on the types of cybercrimes viz. Paytm frauds, ATM fraud, phishing, identity theft, cyber stalking. She quoted the instances of cybercrime to get the insight of cybersecurity. Ransomware attacks are a type of malicious software designed to block access to a computer system until a sum of money is paid. Phishing is a type of scam where criminals encourage targets via email or other online communication method, to perform a certain action. Frauds related to social media, cyber hygiene, were discussed. Madam also shared information on being victim to cybercrime what should be the ideal steps or measures one should take.

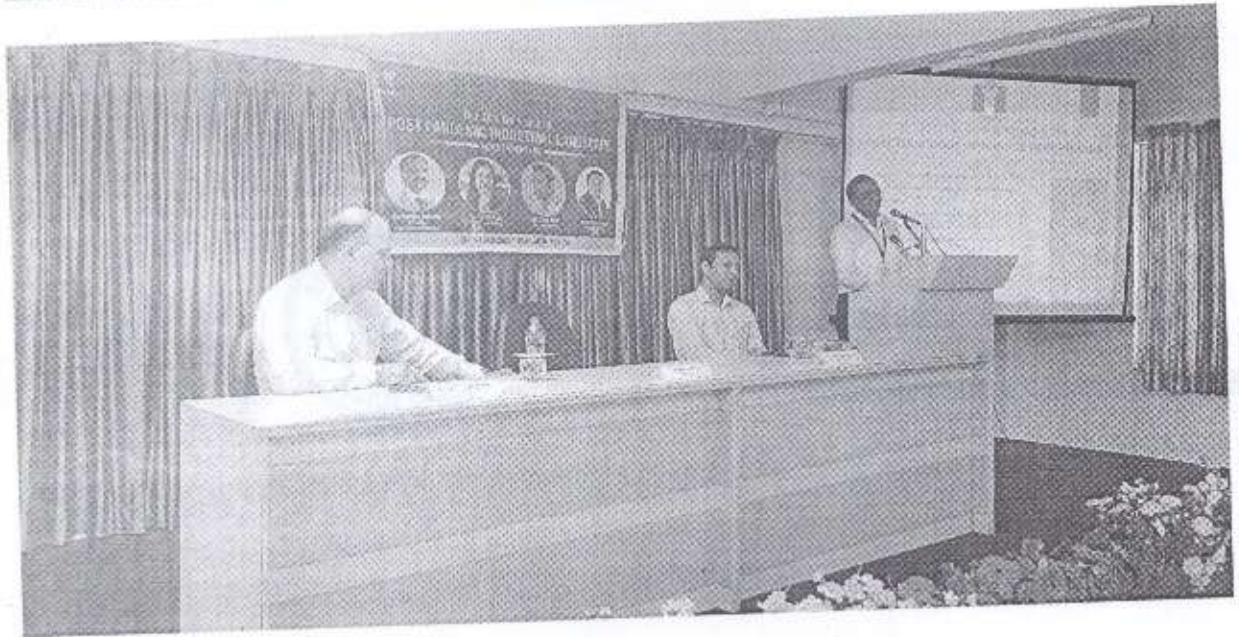
